

# PARTNERING TO ADVANCE INDIGENOUS PRIORITIES

SFI firmly believe that inclusive, collaborative approaches to policy, program, and relationship development lead to real progress on the ground and a positive difference in people’s lives. We have proudly partnered with and invested in over 180 Indigenous communities through our growing suite of Standards, Conservation, Education, and Community programs.

## STANDARDS

SFI can provide Indigenous communities and business with funding and in-kind **Certification Readiness Supports** to achieve a successful third-party forest certification audit.



## CONSERVATION

SFI’s **Conservation Grants Program** offers annual grants, averaging \$30,000-\$60,000 USD, for projects that quantify and demonstrate the value of SFI-certified forestlands, and lands providing fiber through the SFI Fiber Sourcing Standard, toward mitigating climate change impacts, enhancing biodiversity, and protecting water resources.



## COMMUNITY

SFI’s **Community Grants Program** offers annual grants, averaging \$5,000-\$10,000 USD, for projects that promote collaboration with the SFI Network and support local communities’ understanding of the value and benefits from sustainably managed forests.



## EDUCATION

SFI’s **Education Grants Program** offers annual grants, averaging \$3,000-\$10,000 USD, for projects that support the delivery of Project Learning Tree (PLT), an initiative of SFI, programming and partnership development. PLT and PLT Canada also offer professional development and activities and resources to engage children in learning about the environment through the lens of trees and forests.



Career pathways and workforce development supports are also available through PLT and PLT Canada, with mentorship programs, green jobs wage matching in Canada, and resources to inspire the next generation of forest and conservation leaders.

# CERTIFICATION SOLUTIONS FOR FORESTS OF ALL SIZES

## SFI FOREST MANAGEMENT STANDARD

The SFI Forest Management Standard promotes sustainable forestry practices based on 13 Principles, 17 Objectives, 41 Performance Measures and 141 Indicators. These requirements include measures to protect water quality, biodiversity, wildlife habitat, species at risk and forests with exceptional conservation value.

### ELIGIBILITY REQUIREMENTS:

To be eligible for certification under the SFI Forest Management Standard, a forest must:

- Exceed 20,000 hectares under active management for timber production;
- Be under the management of a resource professional, such as a forester;
- Undergo independent audits by competent and accredited certification bodies.

Large, volume-based tenures are also eligible for certification.

## SFI INDIGENOUS PEOPLES & FAMILIES MODULE

The SFI Indigenous Peoples and Families Module provides a pathway for small Indigenous community and family forests to obtain a leading, globally recognized third-party forest certification using requirements that are tailored to their unique needs.

### ELIGIBILITY REQUIREMENTS:

To be eligible for certification under the SFI Indigenous Peoples and Families Module, a forest must:

- Not exceed 20,000 hectares under active management for timber production;
- Be under the management of a resource professional, such as a forester;
- Undergo independent audits by competent and accredited certification bodies.

Small, volume-based tenures are also eligible for certification to the SFI Indigenous Peoples and Families Module.
