New York Certifies State-Owned Forests

NEW YORK STATE RECENTLY announced it has certified all state-owned forestlands outside the Adirondack and Catskill parks to credible programs, including the SFI Standard.

"We're very proud of this recognition," says Pete Grannis, Commissioner of the New York State Department of Environmental Conservation. "It not only validates the state's efforts to practise forestry in an economically, environmentally and socially responsible way, but also adds value to our forest products."

"Sustainable forest management can provide habitat to many species of birds and other wildlife, and also support the economies of rural

International Toolkit highlights SFI advantages

THE WORLD BUSINESS COUNCIL for Sustainable Development and the World Resources Institute recently produced a toolkit to help corporate managers define and implement sound procurement policies when buying products originating from the world's forests.

The guide includes a full report called Sustainable Procurement of Wood and Paper Based Products with the top 10 questions corporate managers should ask when buying forest-based products and a list of resources. There is also a shorter overview report, and a website with a spread-sheet tool.


"Finding credible purchasing information around the complexity of the issues — including forestry, climate change, energy, and manufacturing — has always been a maze," says David J. Refkin, Director of Sustainable

Development at Time Inc. "This is a virtual Rolodex of the issues and resources out there."

The report's introduction includes a table listing the positive attributes of the SFI procurement objectives, such as delivering credible information about products, ensuring they come from legal sources, supporting sustainable forest management and addressing social issues. The full report includes many

references to SFI procurement requirements as well those of the Programme for the Endorsement of Forest Certification schemes (PEFC), which has endorsed the SFI Standard.

New Partners Join Habitat for Humanity Project

St. Louis County Commissioner Keith Nelson became one of the newest partners joining the Minnesota SFI Implementation Committee and the North St. Louis County Habitat for Humanity in the first project in the United States to ensure a Habitat for Humanity home is built using products from well-managed forests.

"The trees we're using are renewable, but the impact they have in helping provide an affordable home for a northern Minnesota family is permanent," said Nelson, who noted that St. Louis was the first public land administrator in the U.S. to license its public lands with the SFI program in 1999.

Nelson is donating Norway pine harvested from his Tree Farm near Eveleth. Cash, materials and services have also been donated by Ainsworth Engineered; Minnesota State Sen. Tom Bakk; Boise Inc.; East Dhu River Sawmill; Forest Capital Partners, LLC; Louisiana Pacific; NewPage Corporation; the Northeastern Lumber Manufacturers Association; Sappi Fine Paper North America; UPM, Blandin Paper Mill; and Verso Paper, Sartell Mill.

Kentucky SIC Creates Employee Forest Resource Education Kits

The Kentucky SFI Implementation Committee provided Forest Resource Education Kits to members of the Kentucky Forest Industries Association (KFIA) at the recent KFIA annual meeting. Committee Chair Dan Allard commended the work of member Grant Curry who spearheaded the effort. The project aims to increase public understanding of forestry and related issues through employees who manage forests and make forest products.

Minnesota SIC names Logger of the Year

The Minnesota SFI Implementation Committee has named Scott Pittack as 2008 Logger of the Year for exemplary work in timber harvest and management. Pittack's company, Pittack Logging is recognized for safe and professional logging operations as well as a commitment to ethical, environmentally sensitive, and aesthetically appropriate harvesting practices.

MEET THE NEWEST SFI INC. BOARD MEMBERS:

ROGER SEDJO

Resources for the Future (environmental chamber)

Roger Sedjo is Senior Fellow and Director of Resources for the Future's Forest Economics and Policy Program. His research interests include forests and global environmental problems; climate change and biodiversity; public lands issues; long-term sustainability of forests; industrial forestry and demand; timber supply modeling; international forestry; global forest trade; forest biotechnology; and land use change. He has written or edited 14 books related to forestry and natural resources.

Sedjo served as a consultant to the World Bank, the Asian Development Bank, the U.S. Agency for International Development, the Food and Agricultural Organization of the United Nations, the Organisation for Economic Cooperation and Development, and other international organizations in more than a dozen countries, including Argentina, Chile, Indonesia, New Zealand, Russia, Romania, Estonia, and Thailand.

Resources for the Future (www.rff.org) is a non-profit and non-partisan organization that conducts independent research — rooted primarily in economics and other social sciences — on environmental, energy, and natural resource issues. Founded in 1952, it became the first think tank devoted exclusively to natural resource and environmental issues.

MIKE ZAGATA

Ruffed Grouse Society (environmental chamber)

Mike Zagata, Executive Director and CEO of the Ruffed Grouse Society, earned a PhD in wildlife ecology from lowa State University. He has taught and conducted research on the impact of forest harvesting on wildlife while in the School of Forest Resources at the University of Maine, Orono.

Zagata served as field director for The Wildlife Society, director of federal relations for the National Audubon Society and program development officer for the National Research Council's Committee on Agriculture. He also served as director of environment, health and safety (EH&S) for Tenneco and as vice-president of EH&S for Transco Energy, and in these capacities was awarded the National Wildlife Federation's Whooping Crane award and the Conservation Fund's Alexander Calder award. Before joining the Ruffed Grouse Society, Zagata was commissioner of New York's Department of Environmental Conservation.

Zagata was inducted into the Offshore Energy Industry's Hall of Fame for pioneering the Wetland Mitigation Banking and Rigs to Reefs programs, and was also recently inducted into the New York State Outdoorsman's Hall of Fame.

The Ruffed Grouse Society (www.ruffedgrouse society.org) was established in 1961 and supports national scientific conservation and management efforts to ensure the future of grouse and woodcock. It

employs a team of wildlife biologists to work with private and public landowners who are interested in improving their land for ruffed grouse, American woodcock and the other songbirds and wildlife that have similar requirements.

BOB LUOTO

Representing independent logging professionals and the American Loggers Council (social chamber)

Bob Luoto has worked in the forest sector for 34 years, and represents logging professionals and the American Loggers Council (ALC) on the SFI Inc. Board. Luoto has been with the ALC since it was created in 1994, and was president in 2002. He has been involved with Associated Oregon Loggers (AOL) for 31 years, serving as board president in 1995 and 1996. He was president of the AOL when Oregon joined the Log a Load for Kids program in support of children's hospitals. In 2001, he was named AOL Logger of the year for his active role in both his community and the timber industry.

Luoto earned a BA in political science from Washington State University then helped establish a family-owned logging company, Luoto Logging Inc. He founded Crown & Cross Inc. in 1998 after his father retired.

Earlier in his career, Luoto was directly involved in a job that protected a number of streams and water systems within the logging unit and won Luoto Logging the Northwest Oregon Area Operator of the Year award. His commitment to safety was recognized in 1990 when he was appointed to Oregon's State Advisory Board for Occupational Safety and Health.

The ALC (www.americanloggers.org) provides a unified voice on logging issues and cooperates with public, industrial and private timberland owners to further sustainable forestry practices. It represents more than 50,000 employees and reaches over 10,000 logging contractors across the United States.

HANK KETCHAM

West Fraser Timber Co. Ltd. (economic chamber)

Hank Ketcham began his career with West Fraser in 1973 and worked in mill level and management positions. In 1985, he was elected President and Chief Executive Officer and in 1996 he took on the additional position of Chairman of the Board. West Fraser operates mills in both Canada and the United States, which provides Ketcham with a broad perspective on how the SFI program can best strengthen forest management across North America.

West Fraser (www.westfraser.com) employs approximately 9,000 people in western Canada and the southern United States. The integrated forest products company is one of the largest lumber producers in North America and also produces MDF, plywood, LVL, pulp, linerboard, kraft paper and newsprint.

Eco-friendly printing goes mainstream

An SFI Inc. advertorial in the April issue of American Printer (http://americanprinter.com) pointed out eco-friendly printing products are no longer a niche market, and options go far beyond recycled content. It noted the value of SFI certification in meeting the sustainability goals of both printers and their clients.

"By achieving certification, printers join a growing community of companies, land-owners, and social and environmental organizations all committed to improving forest practices on a global scale. SFI-Certified Products Conserve Turkey Habitat

A great way to conserve wild turkey habitat is to ask for SFI-certified wood products and stay clear of foreign-grown exotics. That's the view of Dr. James Earl Kennamer, Senior Vice President of Conservation Programs for the National Wild Turkey Federation.

In the March/April edition of Turkey Call, which reaches over 400,000 federation members, Kennamer challenged the view that bamboo floors are a better environmental choice than home-grown hardwood. He noted that SFI program participants identify and protect important wildlife habitat on both certified and non-certified lands, which is important to hunters. "For example, SFI certification ensures important wild turkey habitats, such as streamside management zones, are left in place after a timber harvest to protect soil, water and wildlife habitat."

Fact Sheet Promotes SFI Fiber Sourcing

SFI INC. HAS PRODUCED a new fact sheet to promote the unique fiber sourcing requirements that set it apart from other

certification standards and address the fact that 90 percent of the world's forests are not certified to any credible standard.

SFI program participants are required to track fiber from uncertified sources, and promote responsible forestry by encouraging landowners to reforest areas that have been harvested, to use best management practices for protecting water quality and to identify and protect or create important habitat elements for wildlife, including imperiled and critically imperiled species and communities.


For areas outside of North America without effective laws, SFI program participants must take measures to procure all fiber from known and legal sources. They also must complete a risk assessment to avoid illegal sources and promote conservation of biodiversity hotspots and major tropical wilderness areas as defined by Conservation International.

Here are the simple steps to add the GIF to your email signature in Microsoft Outlook.

- · Open Microsoft Outlook
- Click on "Tools" on the menu bar
- Click on "Options" (last line item in pull-down menu)
- Click on "Mail Format" (third tab across the top)
- · Click on "Signatures"
- · Choose your regular Signature and click "Edit"
- A text box will pop up then. Scroll down to the bottom of your current Signature and right click on the white of the text box.

- A window will prompt you to find your Picture Source. Click "Browse" and locate the SFI email GIF on your computer.

CLAIM: The SFI program is controlled by the forest industry.

THE FACTS:

- SFI Inc. is a registered charitable organization under section 501(c)(3) of the United States Internal Revenue Code, which means it cannot be organized or operated for the benefit of private interests and its net earnings cannot benefit any private shareholder or individual.
- The SFI program is a single North America-wide forest certification standard promoting responsible forest management. It is globally recognized and endorsed.
- SFI Inc.'s three-chamber Board of Directors represents economic, environmental and social interests equally, and is totally responsible for the SFI program.
- Current board members include representatives of environmental, conservation, professional and academic groups, public officials, labor, the forest products industry, independent logging professionals and forest landowners. As terms expire or vacancies occur, a nominations committee representing all three sectors prepares a list of nominations for election to the board.
- In order to ensure that no sector can control the future of the corporation, board actions must be approved by a minimum of 80 percent of those present
 — which must include at least two representatives from each sector or a proxy.
- A 2007 study conducted by the Pinchot Institute for Conservation to help the U.S. Forest Service assess the value and implications of certifying public lands found, among other things, that both the SFI and FSC standards cover an appropriate balance between economic, environmental and social concerns.

communities," says Albert E. Caccese, Executive Director of Audubon New York.

Independent certification bodies NSF-International and Scientific Certification Systems audited the state's forest practices and forest management plan against the SFI and Forest Stewardship Council standards. The state had to meet strict measures in nine categories, including sustainable practices, forest health, biological diversity and soil and water protection.
