## **FORESTS CERTIFIED TO SFI**

SFI has 34 SFI Implementation Committees representing close to 1,000 volunteers in 43 states and provinces. They are a critical part of the program promoting the SFI Standards, collaborating on the training of harvesting professionals and connecting people and communities to the forest.

Forests certified to the SFI Forest Management Standard cover more than a quarter-billion acres/100 million hectares, stretching from Canada's boreal forest to the U.S. South.

Currently there is over 24.9 million hectares of forestland in B.C., 10.9 million hectares in Alberta and 4.6 million hectares in Saskatchewan certified to the SFI Program.
